## Defensive Growth Portfolio

Portfolio Factsheet as at 31<sup>st</sup> July 2023

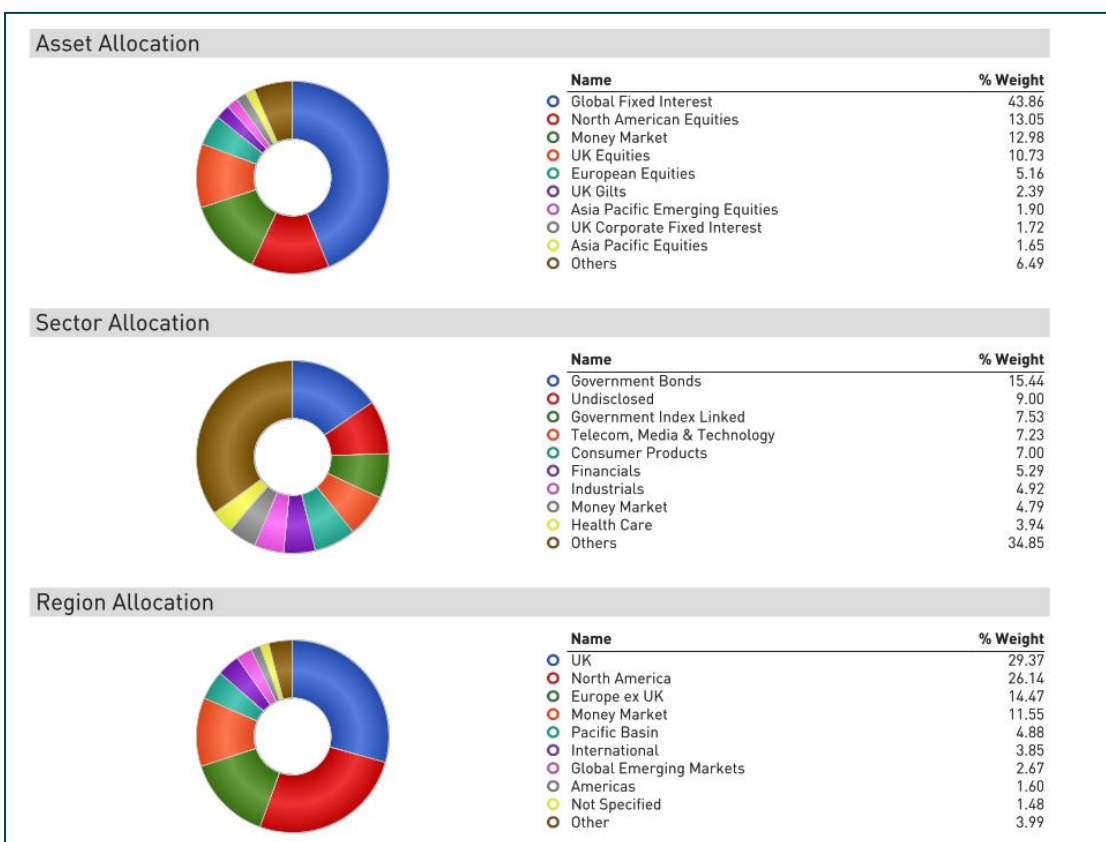


**Objective:** The CDI Defensive Growth portfolio invests in a blend of Equities (both UK and Global) which account for around 30% to 35% of the portfolio by weight, with the fund selection aiming to generate a modest level of natural income together with capital growth. The remainder of the portfolio is held in Government and Corporate Fixed Interest Securities (again both UK and Overseas) and other assets, such as infrastructure, to add further diversification.

**Target Market:** This portfolio is suitable for investors with a time horizon of 5 years or more who are willing to accept Low to Medium levels of investment risk in return for the potential for participation in rising investment markets. This fund is not designed for investors who cannot afford more than a modest loss of their investment.
