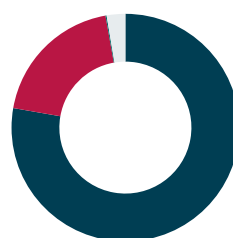

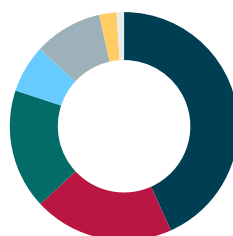

Region Allocation

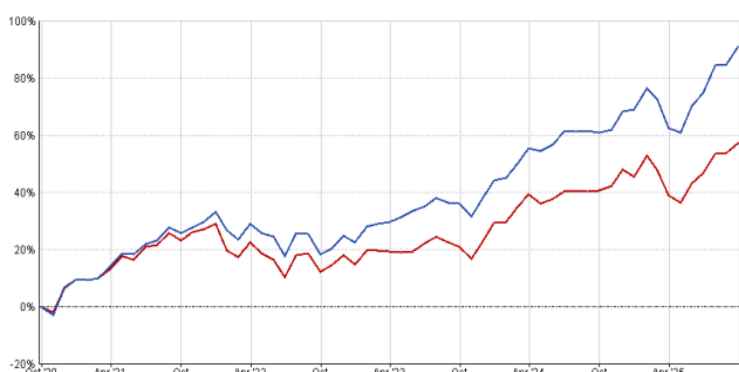
